Membership

Only Members registered with the Institute are permitted to write examinations.

The closing date for registering for membership for those wishing to write the:

- **April Exams: 31 March**
- **October Exams: 30 September**

Membership subscriptions must be renewed by the 1st of January annually. Subs not paid by the 1st of January will attract a **penalty** equivalent to the current membership fee. Members are encouraged to pay on time.

Qualification for Admissions as:

1. **Ordinary Members** - Applicant must be employed by a sponsor bank of the Institute and must submit a letter from employer confirming whether employed on a permanent or contract basis.

2. **Affiliate Member** - Applicant must have at least two A 'Levels and must submit proof of qualification together with proof of residence (amenities bill within the last 3 months) and certified copy of I.D. Document

An application for admission to membership in any of the above categories shall be made on a form sent and approved by the Council of the Institute.
